If most of your deliveries are more valuable than \$250.00, you have the option of insuring all deliveries for \$750.00 at a discounted rate of 50 cents per delivery. With this option, every shipment will have 50 cents added to the delivery charge. Additional insurance above the \$750.00 is still available upon request at the normal rate of insurance.
